



**MEMORANDUM OF UNDERSTANDING**  
**between**  
**THE UNIVERSITY OF ADELAIDE, AUSTRALIA**  
**and**  
**UNIVERSIDAD AUSTRAL DE CHILE**

1. The University of Adelaide and Universidad Austral de Chile wish to collaborate in order to benefit their research and teaching activities, and to further the internationalisation of both universities.
2. The purpose of this Memorandum of Understanding (MOU) is to establish a framework within which co-operation may develop between the two institutions. This will occur within the context of the regulations and policies of each university, and subject to the availability of resources.
3. Co-operation between the two universities may include such activities as:
  - Exchanges of students and academic staff
  - Joint research activities, including seminars, conferences and public lectures
  - Exchange of publications, academic materials and other information
  - Collaborative degree programs at the undergraduate and postgraduate levels
  - Participation in PhD and research masters programs at the University of Adelaide by staff of Universidad Austral de Chile, including under the scholarship program BECAS CHILE and the agreement between the Chilean Ministry of Education and the University of Adelaide
  - Joint quality assurance and benchmarking
  - Such other projects for mutual benefit that are agreed upon by both parties
4. Specific programs or activities will be undertaken under this MOU only after the written agreement of both universities. The terms and conditions of the program or activity, including any financial arrangements, shall be set out in a written Agreement signed by an authorised representative of each university.
5. Both parties shall designate a liaison office for this MOU and for any subordinate agreements under this MOU. For the University of Adelaide, the office shall be the Pro Vice-Chancellor (International). For Universidad Austral de Chile, the liaison office shall be the International Affairs Office.

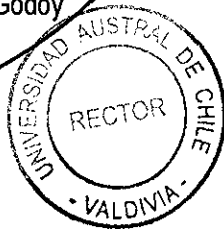

6. This MOU comes into effect when signed by both universities. It will remain in effect for a period of 5 years from that date. Not less than six months prior to its expiry, the two universities will review its operation and decide whether or not to renew it. Any such renewal shall be signed by an authorised representative of each university, and may include variations to this MOU.
7. This MOU may be terminated by the written mutual consent of both universities, or by either university giving 60 days written notice to the other university.
8. This MOU places no financial or legal obligations on either of the universities, nor does it create any legal relationship between them.
9. This MOU is signed in two versions, one in English and one in Spanish. Both are equally valid.
